DISTRICT 003 REPORT SUMMARY

The State of District 3 is strong and stable. All District 3 (D3) Councils are poised to attain the STAR Council status this fraternal year. There are no financially delinquent Councils in District 3. No D3 Councils are suspended. District 3 Councils ensures that all required forms are submitted timely. District 3 Councils attend and actively participate in District Quarterly Meeting. All D3 Councils hold planning meetings and regular business meetings and each offer a wide range of programs that actively challenge and engage the membership. Most D3 Councils have effectively integrated hybrid meeting options using platforms such as Zoom in conjunction with in-person meetings for maximum flexibility in this post-COVID19 era.

Potomac Council initiated COR successfully this year and other D3 Councils are encouraged to follow suit. Washington Council is performing great and their Roundtable in Lebanon is strong and ready to be chartered. They held a March for life and various KofC programs of note. They also out-recruited most regular Councils this year. Oscar Romero Council hosted the Silver Rose this year and led a procession with the Silver Rose through the streets of NW DC to the Basilica which cumulated in Holy Mass and was widely attended, with the Color Corps members from D3 jurisdiction serving during the Mass. D3 Councils participated actively in support of DC State initiatives and programs. They supported the March for Life sign-making project, sign distribution at the National Mall at the March for Life. They supported the offloading and loading of boxes for the Annual Coat for kids' project. They massively supported the Coats distribution at our Lady of Perpetual Help in SE. District 3 hosted 2 very successful Exemplifications of Charity, Unity & Fraternity (ECUF) events which brought in several new Knights into the Order. The membership report bears witness to the relentless efforts of D3 Councils in recruitment this fraternal year, and demonstrates how they effectively utilized both in-person and online exemplification resources available when necessary.

The report below summarizes the leadership demonstrated by D3 Councils this year. The overall quota for D3 was 22 which was exceeded by 32 for a total of 53 new knights recruited (thereby attaining 241 % of the stated quota) already, with at least 2 months to the end of the fraternal year. Each Council recruited over 100% of the assessed intake quota, but for one which still took in over 35% of her quota.
